## M P M SCOPE:

- A. To mobilize required manpower and supervise the work till its completion. Duration to complete the work is 8 days.
- B. Tools and tackles, safety equipment's are of contractor's scope.
- C. Contractors should look after the safety of the workmen, and provide required safety protection equipment's & insure their workmen before taking up any work inside the Mills and should comply with PF Act, insure his workmen and adhere to all Mills safety procedures while on work.
- D. All debris to be transported to the designated place and to clean the area after completion of the work.
- E. Contractors are required to cover their workmen under the Employees State Insurance Corporation (ESI) and Provident Fund Act and furnish the ESI & PF Code No. If it is found that, these are not complied with by the contractor, any amount to be paid towards fee contribution/ fine etc., in this regard shall be borne by the contractor and MPM will not have any responsibility.
- F. Also in respect of workmen who work under this contract, it is the contractor's responsibility to familiarize and abide by the statutory obligations like Act / Rules / Clauses etc., which are in force and / or as amended /modified from time to time by state / central government of relevant departments. Contractor to pay the minimum wages to the workmen who works in this contract as per Labour department.
